- 3. The appointed Assistant Professor(s) will be entitled to enjoy regular U.G.C. scale of pay Rs.15,600 39,100 + AGP 6000 with other allowances as per rule as admissible and eligible.
- 4. This has the concurrence of Govt. Finance S.I.U. Department Letter No.FSI.5/2005/Vol.IV/31, dated 05-04-2010.
- 5. The Principal while accepting the joining report should have maintained that he has been alloted curricular and other academic related duties. However now the Principal will please allot job chart to the incumbent and confirm his performance accordingly.
